- c. - d. <u>Municipal Building as Polling Facility for 2020:</u> Authorize the Township Secretary to execute an agreement whereby the Mount Joy Township Fairview Municipal Building will be used as a polling place for the Primary Election, April 28, 2020 and General Election, November 3, 2020.
- e. <u>2020 Old Trolley Line Park Paving:</u> Authorize the preparation and advertising for paving at Old Trolley Line Park, i.e. overlay a portion of the parking lot and paving of the existing stoned pathways.
- f. <u>Greiner Industries, Inc.; 180079-SWMP-MAJ:</u> Approve a release of Letter of Credit #SB187690001, from its current amount of \$240,631.75, as issued by M & T Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities,
