Minutes of the Regular Meeting of the Mount Joy Township Planning Commission Held on July 25, 2022

- 1. Michael McKinne called the meeting to order at 7:00 p.m. in the Mount Joy Township Municipal Building located at 8853 Elizabethtown Road, Elizabethtown, PA 17022.
- 2. Pledge of Allegiance
- 3. Roll call of the Planning Commission Members:

- 4. Public Comment: NONE
- 5. Consent Calendar:
 - a. Approve and ratify the minutes of the June 27, 2022 meeting
 - b. Authorize signing the Final Subdivision Plan for 1795 Sheaffer Road Subdivision (#21-03-FSDP)

A motion was made by Gerald Cole and seconded by Delmar Oberholtzer to approve the consent calendar. All members present voted in favor of the motion.

- 6. Old Business:
 - a. <u>Preliminary/Final Land Development Plan for Rheems Retail Center (#22-05-FLDP)</u> Proposal to construct a drive-thru lane around an existing gas station/convenience store located at 2040 West Main Street. The 1.79-acre site is located in the C-2 General Commercial District and is served by public water and sewer facilities.

Stacy Longenecker from Light-Heigel Associates presented the project to the Commission. He provided an overview of the proposal to add a drive-thru lane behind the existing convenience store. A parking deficiency was identified during plan preparation due to the actual uses in the adjacent retail center. They are working through final calculations and ways to remedy the deficiency.

Mr. Cole asked the applicant to consider removal of the unused drive-thru at the adjacent retail center building to avoid circulation conflicts with the new drive-thru. Mr. McKinne expressed concern with left turns out of the parking lot onto Route 230. Although the plan is not in a form to be approved due to the outstanding parking space issue, a motion was made by Gerald Cole and seconded by Arlen Mummau to grant waivers of Chapter 119 of the Code of Ordinances of the Township of Mount Joy, i.e. the Mount Joy Township Subdivision and Land Development Ordinance as follows:

- a) §119-25 preliminary plan approval
- b) §119-31.C(3) existing features within 200'

- c) §113-32 volume control requirements
- d) §113-43.I(5) manmade features within 200'

All members present voted in favor of the motion.

7. New Business:

a. <u>Proposed Zoning Amendment for Part of 125 Aberdeen Road from the R – Rural District to the A – Agricultural District</u>

Mr. Evans presented the proposed rezoning on behalf of the landowners, Ben & Alisha Nissley. The rezoning will affect a small area of the 125-acre farm currently zoned Rural, resulting in the entire property being zoned Agricultural. This is a prerequisite of the Lancaster County Agricultural Preserve Board with whom the landowners intend to preserve their farm.

A motion was made by Gerald Cole and seconded by Rodney Boll to forward a recommendation of approval to the Board of Supervisors. All members present voted in favor of the motion.

- 8. Initial View:
 - a. <u>Minor Subdivision Plan for 1319 Bear Creek Road (#22-09-MSDP)</u> Proposal to subdivide a 4.05-acre lot containing an existing homestead from a 40.1-acre tract. A sketch plan for the development of the entire tract was previously reviewed. The property is zoned R-1 Low-Density Residential.

Brian Focht from C2C Design presented the application to subdivide the existing dwelling onto its own lot, reserving the remainder of the tract for a residential development. This new "Lot 1" will be further subdivided through the full development plan in order to construct a new road that will provide frontage access for the existing dwelling. It will be connected to public water and public sewer as the development extends these utilities into the site.

The Commission stated that a nearby neighbor on Meadowbrook Lane provided a letter noting their ongoing ground water and runoff issues with their and surrounding properties. Their request is for the new development to avoid putting more runoff onto the existing homes.

A motion was made by Gerald Cole and seconded by John Dice to grant waivers of Chapter 119 of the Code of Ordinances of the Township of Mount Joy, i.e. the Mount Joy Township Subdivision and Land Development Ordinance as follows:

- a) §119-32.A & §119-34.E(3)(c) water and sewer feasibility report
- b) §119-52.J, §119 §119 deferral of consideration of the requirement to improve the Bear Creek Road frontage to a subsequent development plan
- c) \$119-54.D(3) lot dimension proportions

And having granted such waivers, grant approval of the Minor Subdivision Plan for 1319 Bear Creek Road (the "Plan") prepared by C2C Design Group, Drawing No. FOR-MJT-01, dated July 1, 2022, subject to the following conditions:

- 1. To the extent not otherwise provided in these conditions, Applicant shall address the comments of the Township Engineer's review letter dated July 19, 2022.
- 2. To the extent not otherwise provided in these conditions, Applicant shall address the comments of the Township Solicitor's review letter dated June 24, 2022.
- 3. Applicant shall provide additional right-of-way along the entire Bear Creek Road frontage in accordance with all applicable Township Ordinances through a recorded legal document in a form acceptable to the Township Solicitor.

4. Applicant shall reimburse the Township for all reasonable engineering and legal fees incurred in the review of plans under the Subdivision and Land Development Ordinance, Storm Water Management Ordinance, and other governing ordinances; review or preparation of documentation required in connection with the development; review and approval of financial security and other documentation; inspection of improvements; and for other costs as set forth in these Conditions within 30 days after receipt of an invoice for such fees. If Applicant fails to pay such costs within 30 days after the date of a written invoice for such costs, Applicant shall be in violation of this Condition.

All members present voted in favor of the motion.

- 10. Other Business:

The Commission discussed the Township Official Map and the requirements thereof. Then Mr. Evans provided a brief update on the status and progress of the Pennmark commercial development proposal at the corner of Cloverleaf Road and Route 230.

- 11. The next regular meeting of the Mount Joy Township Planning Commission is scheduled to be held on **Monday**, July 25, 2022 beginning at 7:00 P.M.

- 3. Public Comment: None.
- 4. Approval and ratification of the minutes of the May 10, 2022 meeting:

A motion was made by John L. Felix, Jr. and seconded by William D. Duncan to approve the minutes for the May 10, 2022 meeting as written. All members present voted in favor of the motion.

5. Samuel L. Yoder - Eagle Scout Project - History Board:

Samuel L. Yoder, Troop #51, was in attendance again to present a final draft of his Eagle Scout Project. The Board is very happy with the project. Two spelling errors were pointed out that should be fixed. Mr. Yoder asked about adding a sponsorship to the sign. The Board had no issues with that being done. He asked about the color scheme of the plastic coverings for the post. Gray seemed like the most reasonable. Mr. Evans will look to see if the Township has any leftover shingles from the pavilion that could be used for the project. Mr. Yoder will be doing a PA 1 Call the week of July 4th in anticipation of construction being done the week of July 18th.

A motion was made by John L. Felix, Jr. and seconded by William D. Duncan to approve the Eagle Scout project proposed by Samuel L. Yoder. All members present voted in favor of the motion.

6. Vendors in Township Parks:

When the proposed changes were presented to the Board of Supervisors there was some objection to the requirement of the organization having to have a 501c3. Mr. Cole, who was not at the last Board of Supervisors meeting, felt that this was a way to hold them accountable. The Park & Recreation Board felt that this was a way to make sure the organization was not raising funds for profit. After a lengthy discussion it was decided that the organization needs to be headquartered in either Elizabethtown Area School District or the Donegal School District. Only one vendor per date will be allowed. The vendor is the one that must complete the application and submit the required documentation. The Board also felt there should be an application fee charged to cover the cost of required paperwork.

A motion was made by John L. Felix, Jr. and seconded by William D. Duncan to recommend that the Board of Supervisors approve allowing vendors in the Township parks during games/tournaments to sell food and refreshments; and to change the wording of Chapter 90, §90-3.P(1) to read "Applicants"

must be an established organization within the Elizabethtown Area School District or Donegal School District. All members present voted in favor of the motion.

7. 1319 Bear Creek Road - Sketch Plan:

The sketch plan for the 40-acre tract located at 1319 Bear Creek Road was presented. This will be before the Planning Commission at their June meeting. Forino purchased this property and is proposing to construct 50 single-family homes. The existing house, driveway, and outbuildings will be subdivided. Mr. Evans stated this is a less complicated development than the other ones that have been under review. The Board would like to see a connection to the school property, if possible. The fee-in-lieu money that would be received will be over \$100,000.00.

8. Other Business:

Mr. Cole felt the Board should involve Karen Eberly of GEARS when talks to develop phase 3 of Old Trolley Line Park begin. She will know what type and size of fields are needed.

Bryan Range has resigned his position with the Township. He was the main person for the parks. There has been some talk about contracting out the mowing, which there are pros and cons to doing.

4. Consent Calendar:

- a. Approval and ratification of the minutes of the June 28, 2022 meeting.

After some discussion, David W. Sweigart III made a motion, seconded by Eric Kreider, to discontinue use of the part-time officers, effective December 31, 2022. All members present voted in favor of the motion.
 - c. Chief Mayberry asked the Commission to consider the purchase of three Black Hawk Dynamic Duo Kits to be placed in patrol vehicles in the event an officer needs to breach a secured door. Kevin Baker made a motion, seconded by David W. Sweigart III to approve this purchase in the amount of \$1440. All members present voted in favor of the motion.

The Elizabethtown Regional Sewer Authority (ERSA) met at 6:30 PM at the public meeting room located at 235 Ersa Drive, Elizabethtown, PA with the following members in attendance: Ken Shaffer, John O'Connell, Al Sollenberger, Rick Erb and Dave Sweigart. Roger Snyder was absent. Also present were ERSA Manager, Nick Viscome; Engineer, Byrne Remphrey and Solicitor, George Alspach.

It was motioned by Sollenberger and seconded by Shaffer to approve the minutes of the June 14, 2022 meeting. Motion carried.

General Business:

A. Viscome presented Resolution 2022-1, a resolution modifying sewer line specifications for sanitary sewer construction. Viscome handed out section 2 of the specifications which has been amended to include an alternate to ductile iron laterals.

It was motioned by Sweigart and seconded by Erb to approve Resolution 2022-1. Motion carried.

- B. Remphrey discussed the change in ownership of the Hoffer tract. Up to this point ERSA has been dealing with the Hershey Developers. Recently the Hoffer land was purchased by Schiavaoni LTD and Chiosi LLC. Remphrey also told the Board that he has completed a developer's agreement for this development.
- C. Viscome told the Board that the county hopes to create an easy way to use, updatable and secure online GIS tool to inventory water and sewer capacity across the county which will identify infrastructure and systems constraints. This would help municipalities to make sound decisions about land, economic development and infrastructure. In order to be a participating member, ERSA needs to execute a data sharing agreement.

1. CALL TO ORDER

Chairman Cole called the meeting to order at 7:00 pm.

2. PUBLIC COMMENT

3. BOARD MINUTES

Chairman Cole presented the June 2022 Board Minutes. Mr. Gibble moved to approve; Mr. Hynicker was second; motion unanimously carried. The June 2022 Board Minutes approved as submitted.



4. FINANCIAL REPORT

Mr. Wendel reported that the June Income Statement shows revenues are up 7% when compared to June 2021 and 15% higher when compared to pre-pandemic levels. The increase in programing and participation has led to higher revenues along with a less impactful COVID-19 climate that has seen less restrictions as experienced in previous two summers of 2020 and 2021. As of 7/14/2022, GEARS has nearly \$1.1 million of working capital in our ENB and Truist bank accounts.

Mr. Kroesen moved to approve the June 2022 Financial Report; Mr. Gibble was second; motion unanimously carried. The June 2022 Financial Report approved as submitted.

Mr. Wendel reported that he has been working with our accountant, Mike Reiner on our 2021 financial review. It may be ready for presentation at our September meeting. Will have a more definitive time by our next meeting.

Mr. Wendel presented the GEARS proposed 2023 Maintenance Budget in the amount \$72,125. This is an increase of about 4.4% compared to our current maintenance budget of \$68,941. It is important that we be proactive and prepare a preventative maintenance plan for the next five years. With that in mind, the replacement of our oldest HAVAC unit, one of seven in operation, which is at least 30 years old is budgeted for replacement in 2023. Several of the other units are over 20 years old and have exceeded their useful life. With repair costs increasing for the oldest unit it is in need of replacement. In addition, the replacement of the swing in the community playground was added. It is by our estimation over 30 years old and in need of replacement. The repairs it has undergone may not have resolved the problems that could possibly impact the structural integrity of this piece. It was mentioned that the EACSA has considered the replacement of playground equipment as more program related, however, it is a community playground and it should be viewed as part of the property used by the general public.

Ms. Duncan recommended that since the playground is used exclusively by GEARS for programs during the day that she was agreeable to splitting the cost five ways and sharing the expense with the EACSA.

Ms. Duncan motioned to approve the sharing of the cost of the playground equipment equally split between the four members of the EACSA and GEARS at a cost of \$4,200; Mr. Kroesen was second; motion unanimously carried.



Ms. Duncan motioned to approve the 2023 Maintenance Budget; Mr. Kroesen was second; motion unanimously carried.

• East Donegal Township: Mr. Wendel presented an amendment to the GEARS Agreement adding East Donegal Township and increasing the contribution rate from 18% to 20% for 2023. The amendment was prepared by our legal counsel, Mr. Jeff Shank. The term of the agreement is five years. It commenced in 2020 and will terminate in 2025 with three years remaining.

Ms. Duncan motioned to approve the amendment to the GEARS Agreement; Mr. Hynicker was second; motion unanimously carried.

Mr. Wendel stated that he will forward to our participating municipalities for review.

Mr. Cole asked if the EASD started charging rental fees for facility use?

Mr. Wendel reported that the EASD has no plans based on communication with Dan Forry to institute fees as part the 2022-2023 school year. East Donegal Township is however in discussion with the Donegal School District regarding fees for use of their facilities for GEARS programs.

• **GEARS Reinvestment Fund:** Mr. Wendel reported that after seeking a legal opinion, GEARS is not required to have the permission of staff to be videotaped while working in and around the community center as we move forward with installing cameras. It is recommended that we install signage indicating that camera surveillance is in the area.



- Recreation: Mr. Wendel reported that Summer Playground and Camp Ladybug has attracted 367 participants. Summer Playground will conclude at our four sites the first week of August. Camp Ladybug will conclude on 7/22 with a talent show. Movies in the Park attracted about 300 in July with our final movie set for 8/4. Pictures from Movie in the Park were shared with the board. The fall brochure will be mailed in mid-August. Preparations for our Fall Festival have started and the event is scheduled on 10/22.
- Kids Center: Mr. Wendel reported that 112 kids are currently enrolled in our summer camp program at Bear Creek. Fall enrollment continues to increase with 21 Pre-school, 25 Kindergarten, 20 Bainbridge, 55 East High and 44 Bears Creek students to date. Back to School Night is scheduled on 8/17. It was also announced that we may be receiving a Workforce Grant that can be used to help cover bonuses and other staff retention programs.
- Senior Center: Mr. Wendel reported that there were 22 service days in June with 127 different seniors served including 16 new seniors. The average daily lunch attendance was 17 while Geri Fit attracted 19 participants on average. The Business Expo held on 7/12 was a big success. 82 seniors attended the event while 27 vendors participated. Mr. Wendel shared the activity and meal schedules for the month of July.
- Facility Maintenance: Mr. Wendel shared pictures of recent maintenance projects completed including the painting of the hockey rink and railings outside the gym and the windows outside the main entrance. In addition, the deck in the back of the building was power washed and sealed.
- **Partnership Development**: Mr. Wendel shared a picture of the check presentation at Camp Ladybug that included Dr. Tresse. The funds raised for Camp Ladybug from the Pinnacle Cup Golf Tournament totaled \$5,700.
