a. Waste Management – Advanced Disposal Services Lancaster Landfill, LLC:

Discussion on and, if appropriate, a motion to approve the First Amendment to Host Municipality Service Fee Agreement between the Township of Mount Joy, Pennsylvania and Veolia ES Lancaster, LLC and to authorize the Chairman or Vice-Chairman of Mount Joy Township Board of Supervisors to execute the First Amendment, contingent upon Advanced Disposal Services Lancaster Landfill, LLC's execution of the same.

b. ERSA Drive:

Discussion on and, if appropriate, a motion on whether to consider ERSA Drive for dedication as part of the road system in Mount Joy Township.

Several conditions should be considered: 1) relocation of existing well to maintain the 100' well isolation distance; 2) place UV treatment on the water supply; 3) enter into an agreement holding the Township harmless; and/or 4) have property owner execute a Release Waiver of Subrogation and Indemnification holding the Township harmless.
