The following agenda items will be acted on by a single motion unless any member of the Board of Supervisors wishes to consider an item separately and for that item to be voted on separately:

- a. Select Northwest Savings Bank as the Township depository (banking institution).
- b. Authorize the Chairman, Vice-Chairman, Members of the Mount Joy Township Board of Supervisors, Manager, Treasurer, and Community Development Director/Zoning Officer to sign checks and pay bills <u>before</u> a meeting whereby they would normally be approved for payment. This is done for discount purposes; to avoid penalties; and to facilitate the disbursement process. (Two signatures are required on each check.)
- c. Authorize the Chairman, Vice-Chairman, Members of the Mount Joy Township Board of Supervisors, Manager, and Community Development Director/Zoning Officer to sign Highway Aid checks account ending with 9963. (Two signatures are required on each check.)
- d. Authorize purchase of the 2024 Treasurer's Bond in the amount of \$4,300,000.00.
- e. Authorize the entire Board of Supervisors of Mount Joy Township, Township Manager, Township Secretary, Township Treasurer, and Community Development Director/Zoning Officer to attend

the Annual PA State Association of Township Supervisors Convention to be held April 14-17, 2024 in Hershey, PA and designate the Township Manager as voting delegate.

- f. <u>Calendar Year 2024 Mileage Reimbursement Rate:</u> Establish 67.0 cents per mile as the mileage reimbursement rate for the calendar year 2024 for all miles driven by an employee who utilizes his/her personal vehicle in the performance of his/her employment duties.
- g. <u>Elected Tax Collector</u>: Accept the resignation, effective immediately, of Joel B. Koser as the Elected Tax Collector for Mount Joy Township of which he was elected on November 7, 2023 for a 2-year term.
- h. <u>Municipal Real Estate Tax Collection:</u> Approve, ratify, and confirm the Township Secretary's execution authorizing the Lancaster County Treasurer's Office to collect the municipal real estate taxes effective with the 2024 real estate taxes.
