 - a. Approve and ratify the minutes of the March 18, 2024 meeting.
 - b.  - e. <u>Public Works Department Personnel:</u> Approve the hiring of Bryan S. Hurst as a seasonal parttime Public Works employee according to the Township Manager's Memo, dated April 3, 2024.
 - f. <u>Elizabethtown Regional EMA:</u> Adopt a resolution whereby, upon adoption, Justin S. Evans, MJT Community Development Director/Zoning Officer and Curtis J. Thompson, EMA Coordinator are the authorized signatories of the established account.
 - g. <u>Eagle Scout Project Old Trolley Line Park:</u> Approve the Eagle Scout project from Benjamin Dice, Troop 117, at Old Trolley Line Park for the construction of roofs (dugouts) on the large baseball field to provide shade for the ball players, as recommended by the Park & Recreation Board.
