- 1. Call meeting to order, moment of silence and pledge of allegiance.
- 2. Roll call of the Supervisors.
- 3. Old Business:

Update on the speed study on Homestead Road.

4. Public Comment:

An opportunity for the public to make comments on items included or not included on the agenda. The Board requests each person to offer comments to state their name and address for the record. All remarks are to be limited to five minutes.

## 5. Consent Calendar:

- a. Approve and ratify the minutes of the June 17, 2024 meeting.
- b. Approve payment of all bills via Bill List #13-2024 in the amount of \$473,741.88; Bill List #14-2024 in the amount of \$115,005.28; and ratify the payment of all payrolls for the period of June 14, 2024 through July 11, 2024 inclusive, in the amount of \$42,412.74, which represents two pay periods.
- c. Adopt a resolution whereby, upon adoption, the Chairman, Vice-Chairman, Members of the Mount Joy Township Board of Supervisors, Manager, Treasurer, and Community Development Director/Zoning Officer are authorized to sign checks; and authorize the Chairman, Vice-Chairman, Members of the Mount Joy Township Board of Supervisors, Manager, and Community Development Director/Zoning Officer to sign Highway Aid checks account ending with 9963. (Two signatures are required on each check.)
- d. <u>Postage Machine:</u> Authorize the Township Manager to execute the Lease (60 months), Conversion Request for Fund Transfer, and Why Wait Program Agreement with Quadient Leasing, Inc., 478 Wheelers Farms Road, Milford, CT 06461, to upgrade the postage machine at a monthly cost of \$94.53. (Current monthly cost is \$114.86.)
- e. <u>Personnel Handbook:</u> Adopt a resolution whereby, upon adoption, the Mount Joy Township Personnel Handbook, dated July 15, 2024 is adopted and will become effective immediately. (Anti-Harassment Policy has been updated and the reimbursement for CDL training has been added.)
- f. <u>Northwest Regional Lancaster County Police Commission</u>: Authorize entering into a lease agreement between Mount Joy Township and Northwest Regional Lancaster County Police Commission for a portion of the Mount Joy Township Fairview Municipal Complex for the period retroactive to January 1, 2024 through December 31, 2028.
- g. <u>PennDOT Winter Traffic Services Agreement</u>: Authorize the Chairman or Vice Chairman of the MJT Board of Supervisors to execute/sign the Municipal Winter Traffic Services Agreement

#3900039314 with PennDOT whereby MJT Public Works Department will provide winter maintenance on: Valley View Road, from Grandview Road to Rissermill Road; and Milton Grove Road, from Cloverleaf Road to Elizabethtown Road, for the winter season of 2024-2025.

- h. <u>Rutt, J. Leon: 23-08-FLDP:</u> Accept Letter of Credit, in the amount of \$165,277.20, as issued by Mid Penn Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the Rutt land development plan located at 300 Jonlyn Drive.
- i. <u>Rutt, J. Leon: 1196-03-FLDP:</u> Approve a release of Letter of Credit #1046, from its current amount of \$33,532.40, as issued by Mid Penn Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the Rutt land development plan. Project located at 300 Jonlyn Drive. (Remaining improvements are being secured by the new Letter of Credit.
- j. <u>Rutt, J. Leon; 23-08-FLDP:</u> Approve and sign the Stormwater Management Agreement and Declaration of Easement; Deferred Improvements Agreement; and Agreement Providing for Grant of Road Maintenance Easement and authorize the Township Solicitor to record the aforementioned documents in/at the Lancaster County Courthouse. Project located at 300 Jonlyn Drive.
- k. <u>Heistand, Jonathan & Korina; 22023-SWMP-MAJ:</u> 1) Approve and sign the Amendment to Stormwater Management Agreement and Declaration of Easement and authorize the Township Solicitor to record the aforementioned document in/at the Lancaster County Courthouse; and 2) authorize release in Escrow from its current amount of \$41,138.97 to guarantee the proper installation of all improvements excluding public sewer and public water facilities, associated with the Heistand stormwater management plan located at 200 Trail Road S. contingent on satisfying the Engineers comments in his May 24, 2024 review letter.
- 1. <u>1925 Sheaffer Road Phase 1 (Meridian Heights); 21-15-FLDP:</u> Accept Bond #800177241, in the amount of \$3,658,100.00, as issued by Atlantic Specialty Insurance Company to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the 1925 Sheaffer Road Phase 1 land development plan.
