- 4. The Board of Supervisors held an Executive Session immediately following the November 18, 2024 meeting to discuss personnel issues. Any official action to be taken based upon discussions held during the Executive Session will occur at an open public meeting.

 - a. Approve and ratify the minutes of the November 12, 2024 and November 18, 2024 meetings.
 - b. Approve payment of all bills via Bill List #24-2024 in the amount of \$364,510.85; Bill List #25-2024 in the amount of \$165,353.85; and ratify the payment of all payrolls for the period of November 15, 2024 through December 12, 2024 inclusive, in the amount of \$42,012.53, which represents two pay periods.
 - c. <u>Calendar Year 2025 Meeting Dates and Holiday Schedule:</u> Approve the calendar year 2025 meeting dates and holiday schedule and authorize the Township Secretary to advertise the same.
 - d. <u>Appointment of Certified Public Accountant:</u> Adopt a resolution whereby, upon adoption, the firm of White, Rudy LLC is appointed to serve as Mount Joy Township's independent auditor for Calendar year 2024 in accordance with the firm's proposal dated September 27, 2024, whereby the scope of the annual audit to be performed of the calendar year 2024 is set forth.
 - e. <u>Elizabethtown Regional Sewer Authority Resignation</u>: Accept the resignation of P. Allen Sollenberger as a member of the ERSA Board effective December 31, 2024 as per his letter dated November 19 2024.
 - f. <u>Ketterline, Inc. ERSA Drive Lot 2; 2016-04-FLDP:</u> Approve a reduction of Letter of Credit #3209, in its current amount of \$38,957.46 to \$17,827.47 as issued by First National Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, for the Ketterline land development plan located along ERSA Drive.
