## Mount Joy Township Board of Supervisors June 16, 2025 @ 7:00 p.m. AGENDA

- 1. Call meeting to order, moment of silence and pledge of allegiance.
- 2. Roll call of the Supervisors.
- 3. The Board of Supervisors held an Executive Session on May 27, 2025 to discuss personnel issues. Any official action to be taken based upon discussion held during the Executive Session will occur at an open public meeting.
- 4. Public Comment:

An opportunity for the public to make comments on items included or not included on the agenda. The Board requests each person to offer comments to state their name and address for the record. All remarks are to be limited to five minutes.

- 5. Consent Calendar:
  - a. Approve and ratify the minutes of the May 12, 2025 meetings.
  - Approve payment of all bills via Bill List #10-2025 in the amount of \$713,706.33; and Bill List #11-2025 in the amount of \$366,306.90 and ratify the payment of all payrolls for the period of May 2, 2025 through June 12, 2025 inclusive, in the amount of \$68,884.31 which represents three pay periods.
  - c. <u>Petty Cash Fund:</u> Authorize the Township Treasurer to decrease the amount of Petty Cash from the current amount of \$1,000.00 to \$500.00.
  - d. <u>Fund Consolidation / Closure Emergency Services Fund:</u> Adopt a resolution whereby, upon adoption, the consolidation and closure of a Capital Reserve Fund for the purpose of providing funding for capital outlay expenditures of the Emergency Service Organization serving the Township will be completed.
  - e. <u>GEARS</u>: ) Recommend approval of the Articles of Incorporation Nonprofit for GEARS; and 2) approve the revised GEARS Funding Agreement between the four municipalities and GEARS.
  - f. <u>Old Trolley Line Park Grant:</u> Adopt a resolution whereby, upon adoption, the Chairman of the Board of Supervisors is authorized to sign the grant application for the Greenways, Trails and Recreation Program (GTRP) that is being submitted for Old Trolley Line Park Phase 3.
  - g. <u>Westmount (Vistablock LLC); 24-1-PLDP:</u> Adopt a resolution whereby, upon adoption, the sewer planning module is approved Westmount Land Development Plan and authorize the Township Secretary to forward the same onto the Regional Office of the PA Department of Environmental Protection for approval.
  - h. <u>Bear Creek Estates; 24-23-FLDP;</u> Approve a reduction of Letter of Credit #230020148, in its current amount of \$3,135,793.21 to \$1,797,569.90 as issued by Univest Bank & Trust to guarantee the proper installation of all improvements, excluding public sewer and public water

facilities, for the Bear Creek Estates land development plan located along Sheaffer Road and East College Ave.

- i. <u>Klein Mills (1376 Campus Rd) Phase 1A (Shared); 22-15-FLDP:</u> Approve reduction of Letter of Credit #6000023006, in its current amount of \$625,719.19 to \$327,622.49, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements within the public right-of-way, excluding public sewer and public water facilities, for the 1376 Campus Road land development plan.
- j. <u>Klein Mills (1376 Campus Rd) Phase 1A (SFD); 22-15-FLDP:</u> Approve a reduction of Letter of Credit #6000023009, in the amount of \$1,700,696.25 to \$1,025,243.77, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the 1376 Campus Rd land development plan.
- k. <u>Klein Mills (1376 Campus Rd) Phase 2 (Shared); 24-20-FLDP:</u> 1) Approve and sign the Land Development Agreement; and 2) Accept Letter of Credit #25-06, in the amount of \$261,832.08, as issued by Orrstown Bank to guarantee the proper installation of all improvements within the public right-of-way, excluding public sewer and public water facilities, associated with the Klein Mills land development plan located along Campus Road.
- Klein Mills (1376 Campus Rd) Phase 2 (SFD); 24-20-FLDP: Accept Letter of Credit #25-07 in the amount of \$373,239.63, as issued by Orrstown Bank to guarantee the proper installation of all improvement, excluding public sewer and public water facilities, associated with the Klein Mills land development plan located along Campus Road.
- m. <u>Klein Mills (1376 Campus Road) Phase 2; 24-20-FLDP:</u> Approve and sign the Stormwater Management Agreement and Declaration of Easement and authorize the Township Solicitor to record the aforementioned document in/at the Lancaster County Courthouse.
