- 2. Roll call of the Supervisors.

3. Public Comment:

4. Consent Calendar:

- a. Approve and ratify the minutes of the July 21, 2025 meetings.
- b. Approve payment of all bills via Bill List #15-2025 in the amount of \$255,143.75; Bill List 16-2025 in the amount of \$343,178.63; and ratify the payment of all payrolls for the period of July 11, 2025 through August 7, 2025 inclusive, in the amount of \$44,291.77 which represents two pay periods.
- c. <u>Personnel:</u> Appoint Justin S. Evans at the Township's Stormwater Management Officer retroactive to July 16, 2025.
- d. PennDOT Winter Traffic Services Agreement: 1) Adopt a resolution whereby, upon adoption, Mount joy Township Enters into a 5-Year Winter Traffic Services Agreement; and 2) authorize the Chairman or Vice Chairman of the MJT Board of Supervisors to execute/sign Worker Protection and Investment Certification Form and the Municipal Winter Traffic Services Agreement with PennDOT whereby MJT Public Works Department will provide winter maintenance on: Milton Grove Road, from Cloverleaf Road to Elizabethtown Road, for the winter season of 2025-2026.
- e. <u>Chapter 98 Residential Rental Unit Licenses:</u> Adopt a resolution whereby, upon adoption, the fees for the issuance of Residential Rental Unit Licenses, the performance of Residential Rental Unit Inspections and the Administration of the Rental Property Management Code with Mount Joy Township is amended.
- f. Meridian Heights (1925 Sheaffer Road) Phase 1; 21-15-FLDP: Approve a reduction of Bond #800177241 from its current amount of \$3,658,100.00 to \$1,548,477.81 to guarantee the proper installation of all improvements excluding public sewer and public water facilities, associated with the Meridian Heights land development plan along Sheaffer Road.
